

BOARD MEETING MINUTES

CGS Boat Shed Monday 15th March 2021

1. Attendees:

2. Register of Interests:

A Register of Interests policy and template was circulated with the Board Papers. The Board agreed to adopt the policy and template and will populate the template prior to the next Board meeting. Board members will be asked to advise at each board meeting any possible conflict of interest relating to agenda items for that meeting.

3. Welcome to Tobi Wehr-Candler in his first board meeting as an appointed member of the board. Congratulations to ACT rowers, including board member Luke Letcher, who were named in the Australian Rowing Team for Tokyo 2021. Congratulations to the ACT Schools (CGS, CGGS, Radford, Marist, Daramalan, Orana) who competed in the Rowing NSW Schools Head of the River over the weekend of the 13th and 14th of March – great results from ACT schools.

4. Director of Finance Report:

- a) A summary statement to the board papers has been circulated in addition to the full report. Financial reports were circulated to all members prior to the meeting.
- b) Overall, financial position is strong. Going forward we our looking to be out of the COVID support cycle, into a normal cycle. Cash Balance is at an all-time high, and the balance sheet is strong.

- c) Seats fees are down on previous years, possibly due to COVID and also with trialling the two double-header regattas, with ACT Juniors and Open Championships split this may have affected the numbers in the ACT Open and Masters Championships
- d) Look to do replacements on infrastructure in the coming months Alison Creagh has asked Edwin Bien to do an inventory and report on regatta technology infrastructure to determine what needs to be replaced.
- e) Review of Seat fees and whether they are able to cover the regatta costs.

Action: Kent Peters to look into this review.

f) Financial statements: Neil Smith proposed, Luke Letcher seconded. CARRIED

5. Executive Officer report:

- a) Have come to the end of the regatta season. Overall numbers in regattas were down on previous years, however still strong given current circumstances.
- b) The two double-header regattas of ACT Head of the Lake/Junior Championships and ACT Open and Masters Championships appeared to work well. Combined numbers were higher than previous years. Format worked well however there will need to be some adjustments for 2022. Three visiting schools attended for the HotL/Junior Championships (Kinross, Redlands, Cranbrook) and two visiting clubs for ACT Championships (Newcastle and North Shore)
- c) End-of-season presentation to award trophies and overall pennant winners.

Action: EO and Sarah Davoran to organise and advise on details.

- d) Board to consider how to create bigger events going forward, looking into sponsorship and partnerships with local organisations. Ben Page has put together a sponsorship document to be put to the board at the next meeting.
- e) Sally Clark to prepare end of season wrap up to be presented at a future board meeting. The Regatta Sub-Committee will also conduct an end-of-season review and report to the board.

6. Items for Decision:

- a) Rowing Australia Special General Meeting:
 - i. The RA SGM will now meet to consider the resolution in the resolution has changed since it was previously presented to the board.
 - ii. The board agreed with the resolution.

Action: Rowing ACT will approve the resolution when it is put forward at the RA SGM

- b) Coastal Rowing Championships (Ben Page):
 - i. RA is now accepting expressions of interests (EOI) to host the Australian Coastal Rowing Championships for the next three years.
 - ii. Ben Page submitted a proposal recommending Rowing ACT submit an EOI for the ACRC for 2024 or 2026 as our preferred years, with December or January being presented as the preferred timing.
 - iii. Canberra Yacht Club has been considered as a potential location for an ACRC the Canberra Yacht Club has indicated their supportive of this idea.
 - iv. The Proposal was accepted by the board.

Action: Rowing ACT EOI for the ACRC for 2024 or 2026 to be submitted to RA for consideration.

- c) Audit of Grade Scores (Alison Chinn):
 - Issue was previously brought to the attention of the board where rowers were not being recognised for their wins and losses on Rowing Manager and RP7.
 Alison Chinn was asked to prepare an audit for the board.
 - ii. Audit found that around 180/200 rowers were not recognised for their results across the season and of these 118 required a change in their grade scores.

Action: Sally Clark to update the grade scores prior to the Edward Trickett regatta in Sydney on the 17-18 April.

- iii. It was recommended that anomalies in grade scores e accepted and the board agreed with this approach.
- d) RACT Masters Interstate Squad Selection (not on the agenda):

7. Minutes from the previous meeting:

a. Neil Smith proposed, Ben Page seconded. Minutes CARRIED.

8. Action Items:

- a. Sally Clark has prepared a letter to go to CRC regarding the outcome of the board's discussion on Women competing in men's events. Email to be sent.
- b. Working groups on safety and women participating in men's events have not had the opportunity to progress further since the last meeting.
- c. Register of Interests Process Alison Creagh has prepared a spreadsheet and document to be distributed, which records the register of interests of each of the board members and will be kept and monitored by Sally Clark. Board members to fill out the spreadsheet and send back to Sally Clark.

9. WHS Review:

a. Alan Butorac has prepared a report. This will be distributed and discussed at a future board meeting.

10. Safety:

a. A Masters Rower capsized outside of the Men's NTC as a result of storm generating adverse weather conditions – she was helped to shore by a NTC rower. The NTC

- submitted an incident report however the individual who capsized did not submit a report.
- b. Issue was raised regarding Go-Boats and other lake users travelling in the early morning without sufficient lighting. This was a particular issue during the balloon festival which has since concluded. This issue has been reported to the NCA by the Rowing ACT EO.
- c. Sarah Davoran to prepare a safety bulletin to go out to the clubs, reminding rowers of lake rules, the need to report safety incidents, and warnings regarding Blue Green Algae on the lake, as well as cold weather reminders due to the cold snap we are currently experiencing.

11. Items for Discussion:

- a) Trophies in the ACT (Sally Clark):
 - An inventory of the trophies within the ACT will be prepared by Sally Clarkover the coming months to determine what trophies we have, and what events do not have a trophy.
 - Their Excellencies, the Governor-General and Mrs Hurley have offered to donate a
 trophy to bolster trophy stocks for the ACT Junior Championships as it was noted
 that there was a limited amount. It was also noted that there was an imbalance of
 trophies for women/girls and men/boys events and that Rowing ACT should review
 events and trophy allocation to appropriate recognition for key events.
 - Another offer has been received to donate a trophy Alison Creagh has asked them to prepare a letter to board.

b) Strategic Plan:

- Board is looking to meet in early May to discuss the Rowing ACT Strategic Plan.
- Sally Clark will send out a Poll to determine the best availability for all members of the board.

12. Items for noting:

- a) Lake Users Group Meeting Report:
 - Blue-Green Algae bloom. From an NCA perspective, limited amount that can be done apart from raising public awareness. BGA information to go in the safety bulletin.
 - Sea-plane was raised with the LUG. Briefings will be provided to Rowing ACT and the LUG once public consultation commences.
 - Discussion around the on-water safety of the balloon festival. David Wright (NCA) will look into this, and get back to the board offline
- b) Alison Creagh accompanied CEO RA to a meeting with Minister Berry regarding the Sea-Plane proposal.
- c) Renae Domaschenz has given notice that she will be finishing up as Rowing ACT Assistant Coach on the 16 April. She will remain a part of the broader rowing community, continue to coach Kathryn Ross and operate as an athlete out of the ACTAS/Rowing ACT Boatshed given her selection as cox for the Australian PR3 4+.
 - The board would use this opportunity to consider what the HP program is achieving and whether it has delivered on its outcomes.
 - Alison Creagh has asked Dave Fraumano to consider what he wants out of an assistant coach.
 - Any changes in position description will need to go through the boar and PPMG.

- d) The board would like to thank all the BROs and volunteers who participated in ACT Open and Masters Championships over the weekend. In particular, the board recognises those who worked through the pouring rain on Sunday of the Masters Championships.
- e) The board wished good luck to all the ACT competitors at the 2021 Australian Rowing Championships, to be held at Lake Barrington, Tasmania from the 22-28 March.
- f) Tobi W-C and Kent Peters will undertake a base costing exercise to better determine regatta costs, seat fees and forecasting.
- g) Catherine Garrington would like to see further BRO development opportunities and pathways established to make use of our three Internationally accredited umpires.
- h) Tobi W-C asked that the board consider topics for consideration by the Regatta Sub-Committee as well as other sub-committees.
- i) Alison Chinn asked that the alternate order of events for the regattas be reviewed. The board agreed that the concept of an alternate order of events is good, however the Order of Events requires actual order may need some re-evaluation.

ROWING ACT BOARD PAPERS – 15 MARCH 2021

Items for decision:

a. Rowing Australia Special General Meeting Resolution - Paper attached - Alison Creagh

Rowing Australia has requested a Special General Meeting be convened to consider a Resolution that seeks to amend the Rowing Australia Constitution. The Rowing ACT Board has previously considered the proposed resolution that amends the Constitution. You should note that there have been very minor changes to the proposed Resolution. Your previously agreed to support the Resolution. The papers provided for the Rowing Australia SGM are attached for Board Consideration.

Action: The Rowing ACT Board is asked to **agree/disagree** with Resolution and provide guidance to the ACT Rowing Australia Councillor (President Rowing ACT) who will attend the Rowing Australia Special General Meeting on behalf of Rowing ACT.

b. Australian Coastal Rowing & Beach Sprints Championships - ACT Expression of Interest - Paper attached - Ben Page

Rowing Australia has called for Expressions of Interest to host the 2021 Australian Coastal Rowing and Beach Sprints Championships (ACR&BSC); and has also called for EOIs for States/Territories who wish to be considered to host the event in future years. As such, Rowing ACT has prepared an EOI (attached) to host the event in either 2024 or 2026.

The proposal is for the event to be hosted at Lotus Bay (in vicinity of the Canberra Yacht Club) over a weekend (with one day each for Coastal Rowing and Beach Sprints). Early discussions with the Canberra Yacht Club have indicated their strong support for the event, including access to their equipment and land as required. Rowing ACT has also reached out to EventsACT for their early inprincipal support.

An ACT-hosted event would provide a unique experience for competitors and spectators alike, and further the sport in the ACT. As well, the event would put ACT back 'on the map' as a destination for national-level rowing events (and support future bids for the return of an AMRC). The 2024 or 2026 timeframe would also allow for the event to be embedded in the National Calendar before being hosted in the ACT, and greater certainty around competitors numbers and event size.

Rowing Australia is expected to provide the financial backing to the event, and the ACT would be expected to provide some staffing support in the lead up, and a small number of volunteers for the event itself. This is assessed within the scope of the ACT to provide.

Action: The Board is asked to endorse the ACT EOI for submission to Rowing Australia.

c. Audit of grade scores - Paper attached - Alison Chinn
