Regatta News

The ANU regatta was a great success with just over 1000 seats. We were down on BRO numbers and it made it challenging at times for the BRO's given the weather conditions.

We have over 1100 seats at the CGS regatta. Fines will be in place for the upcoming CGS regatta. Volunteer sign up has been excellent and there is an increase in the number of BROs for the regatta.

Preparations are underway for the Head of the Lake and the ACT Junior championships. Principals from all the Canberra schools are confirmed.

Their excellencies have confirmed they will attend the ACT Junior Championships. We also have the Letcher and Grzeskowiak family attending to present their donated trophies.

8. Safety Sub-Committee Report (Sally Clark)

WHS and Safety Incidents Report (Sally Clark)

Several safety incidents reported and reviewed by the EO and President.

Safety Sub-Committee to meet in late Feb/Early March to review all safety related actions and recent incident reports.

9. Items for Decision

a. Head races for the 2021/22 Season - Sally

The board considered a number of options for running the Head of the Molonglo and Col Panton from the 2021/22 season, and the practicalities of running them at the end of the season. The options considered were;

- 1) Running Both Head Races at the end of April and beginning of May
- 2) Run only one Head Race
- 3) Running neither event and having no Head Races during the 2021/22 Season

DECISION: No Head Races will be conducted this season. Head Races should be scheduled early in the 22/23 season.

b. Interstate crew selections - Dave F

The Selection Panel and Head Coach recommended crews for Board for approval. There were insufficient nominations for a Queens Cup or a Victoria's Cup crew. The remaining boats were ranked as priorities to send to 2022 ARC with the Youth Eights and Penrith Cup being top priorities to be selected. Remaining male nominees chose not to proceed with Kings Cup selection.

Nominees for the Penrith Cup, Wilkinson Cup (Men's Youth Eight) and Bicentennial Trophy (Women's Youth Eight) participated in a speed order trial to determine if crews would be viable for the Interstate Competition.

Both Youth Eights determined that they would like to compete at Nationals following the trials and have received Selector Approval. The Penrith Cup crew felt that they were not competitive enough, and that they would not have enough time to train together to develop a strong crew and therefore elected not to put a crew up for nomination to the board.

Single Scullers have been selected based on their results at NSW State Championships.

The Board advised that approval would be provided out of session after detailed review of the selection documentation.

DECISION: Head Coach to provide a Selectors Report, that includes the recommended coaches, for out-of-session Board response by the Thursday 24th February. Interstate crews will be announced on Friday the 25th of February. A review of the selection process will be conducted after 2022 ARC. The Board asked that a new Ombudsman be advised due to the absence of the named Ombudsman.

c. Masters selection - Neil/Luke

With the 2022 AMRC relocated to Ballarat, VIC the Board discussed the implications for the current Masters selection process.

DECISION: The Board asked that crews previously identified confirm that the will be attending the 2022 AMRC in Ballarat. The Board also decided to reopen selection for the Masters Women's and Men's eights only. This information is to be distributed to the Masters community as soon as possible.

10. Items for Discussion

a. Strategic Plan Update - Sally

The Board was asked to decide if the second Strategic Planning session should be postponed, cancelled or changed to an online format.

As the plan is in the draft phase, the board would like to see the Participation, Performance and Pathways plans separated.

The board will consider how to gather community consultation

DECISION: The community consultation date will be postponed, with the board to look for a more suitable date. In the meantime, Sally will continue to work on the plan

b. Rowing ACT Website - Sally

The Rowing ACT website has historically been managed by Vince McMahon. The website and content needs review. This is a project that the EO will not have time to address until the end of the 2021/2022 season. Assistance from a web designer will be required. Any ideas or thoughts to drive this project would be appreciated.

DECISION: The EO is to seek quotes and report back to the Board.

c. Rowing ACT appointments including Board positions - Alison Cr

Not discussed.

11. Items for Noting

a. RiAWG ACT Nomination

Nick Hunter has accepted Rowing ACT's request to be the nominee to the Rowing in Australia Working Group. RA has not yet advised membership of the RiAWG.

b. Artwork installation in Central Basin

The proposed artwork will be a temporary installation from March – August 2022. The EO has asked NCA to place safety buoys and lighting around the installation to reduce the safety hazard for rowers. Also the ACT rowing community will be advised through newsletters and social media.

12. Other Business

Ben Page requested Rowing ACT consider supporting ACT State Technical Officials who attend the Australian Rowing Championships.

Neil Smith requested the Board update the community on the establishment of Governance and Safety sub-committees and VP role.

Alison Chinn requested the season point score be updated.

Alison Creagh advised that a consultation process was underway for changes to the LBG Lake Ordinance and asked that Clubs and Schools be reminded of the consultation process.
